

OFFICIAL RULES OF CONTEST

REGISTRATION/ENTERY IS REQUIRED. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED DURING THE ENTRY PERIOD.

VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT. BY PARTICIPATING IN THE RAFFLE, EACH ENTRANT SHALL BE BOUND BY THESE OFFICIAL RULES ("OFFICIAL RULES") INCLUDING ALL ELIGIBILITY REQUIREMENTS AND RESTRICTIONS AND ACKNOWLEDGES THAT THE RESULTS OF THE RAFFLE, AS DETERMINED BY SPONSOR, HOST AND THEIR RESPECTIVE AGENTS, ARE FINAL IN ALL RESPECTS.

ELIGIBILITY: The raffle is open only to individuals who are legal residents of the continental United States, who are eighteen (18) years of age or older at the time of entry. The raffle is not open to residents outside of the United States. Officers and directors (including immediate family members of officers and directors (i.e., spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of the Sponsor and their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Raffle are not eligible to participate or win the Prize.

HOW TO ENTER: To enter, follow the entry instructions. Each entrant will be asked to submit an official entry form, which may include, among other things, his/her full name, address (no P.O. Boxes), email address and related registration information as prompted. Entrant must complete and submit the entry form with all required information for the entry to be eligible. As a condition of entering the Raffle, each entrant gives consent for Sponsor and Lykins to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Raffle and to comply with applicable laws, regulations and rules. Any information entrant provides to Sponsor or Lykins may be used to communicate with entrant in relation to this raffle or on a raffle winner's list. Only one entry per person.

Any entries that do not otherwise comply with these Official Rules, will be void. The computer designated by Lykins Companies, Inc. dba Lykins Energy Solutions ("Lykins") shall be the official timekeeper of the Raffle. Entries that are incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Raffle at the sole and absolute discretion of Sponsor and a refund will be given. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Those who do not follow all of the instructions or abide by these Official Rules or other instructions of Sponsor may be disqualified and a refund will be given.

RANDOM DRAWING AND ODDS: There will be one (1) Winner selected in this raffle. The potential Winner of the raffle will be selected by random drawing, subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winner will be declared the official winner of the raffle (the "Winner"). The

decisions of Sponsor are final and binding on all matters relating to the raffle. Odds of winning depend on the total number of eligible entries received during the Entry Period.

WINNER SELECTION: All eligible entries received during the Entry Period will be gathered together into a database at the end of each Entry Period. The potential Winner will be chosen at random from among such pool of entries. The potential Winner will be contacted after the end of the Entry Period. The potential Winner will be contacted via Facebook and by email. Each entrant is responsible for monitoring his/her e-mail account / Facebook account for Prize notification and receipt or other communications related to this raffle. If a potential Prize Winner cannot be reached by Sponsor within 12 hours from the time that Sponsor places message on Facebook and sends an email notice (“Required Response Time”) using the e-mail address provided during entry, that potential Prize Winner shall forfeit the Prize. Upon the request of Sponsor, the potential Winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form and IRS W-9 form (collectively, “Affidavit”). Neither Sponsor nor Lykins is responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant’s email account to receive email messages.

PRIZE CONDITIONS: One (1) Prize Will Be Awarded. All Prize details shall be determined, in the sole and absolute discretion of Sponsor. No compensation will be paid in lieu of lost or Prize or cancelled event. The tickets to the event are subject in all respect to the terms and conditions set forth on the tickets and any requirements of the facility hosting the event. The Released Parties are not responsible for and will not replace any lost, mutilated or stolen Prize(s) or any Prize that is undeliverable or does not reach a Winner because of an incorrect or changed address. If a Winner does not accept or use the

entire Prize, the unaccepted or unused part of the Prize will be forfeited and the Released Parties will have no further obligation with respect to that Prize or portion of the Prize. No more than the stated number of Prize(s) will be awarded. The Released Parties are not responsible for and Winner will not receive the difference, in any, between the actual value of the Prize at the time of award and the stated ARV in these Official Rules or in any Raffle-related correspondence or material. Limit of one (1) Prize per person.

Released Parties: (i) make no warranty, guaranty or representation of any kind concerning the Prize (or any portion thereof), and (ii) DISCLAIM ANY WARRANTY EXPRESSED OR IMPLIED.

Sponsor reserves the right, in its sole discretion, to cancel or suspend the Raffle (or any portion thereof) should virus, bugs, unauthorized human intervention, or other causes corrupt administration, security, fairness, integrity or proper operation of the Raffle (or any portion thereof). In the event of cancellation, Sponsor may elect to identify each Winner and award the Prize by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation. Sponsor also reserves the right, in its sole discretion, to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Raffle.
